
Sir/Madam

1. It may please be recalled that for 2022-2023 approval cycle, the PCI has uploaded the decisions regarding approval of institutions on its website. In some cases, earlier approved intake of students was reduced.
2. The matter was considered by 379 EC in its meeting held on 15.10.2022 which decided as under –
 - a) wherever admission intake was reduced in 2022-2023 academic session in pharmacy course(s), the previous approved intake during 2021-2022 academic session be restored for 2022-2023 academic session also.
 - b) to notify to all such Institutes that an affidavit* should be uploaded on institution's dash board on the portal of Pharmacy Council of India, New Delhi within one month of receipt of this Notification without fail. There should not be any change/modification/alteration in the affidavit provided with this Notification. In case any change is observed, the same will not be entertained at any cost and the liabilities will rest only with the Institute and NOT PCI.

The above decision of 379 EC was notified on Council's website vide notification dt.22.10.2022.

3. In view of above, I am directed to clarify that decisions of Central Council and various Executive Committees reducing the intake in various pharmacy courses are to be read with Council's notification dt.22.10.2022 notifying that wherever admission intake was reduced in 2022-2023 academic session in pharmacy course(s), the previous approved intake during 2021-2022 academic session be restored for 2022-2023 academic session also.
