

RESPONSIBILITIES OF ANTI-RAGGING COMMITTEE

On receipt of the recommendation of the Anti-ragging Squad or on receipt of any information concerning any reported incident of ragging, the committee shall immediately determine if a case under the panel laws is made out and if so, either on his own or through a member of the Anti-Ragging Committee authorized by him in this behalf, proceed to First Information Report (FIR), within 24 hours of receipt of such information or recommendation, with the police and local authorities, under the appropriate penal provisions relating to one or more of the following, namely:

1. Abetment to ragging
2. Criminal conspiracy to rag
3. Unlawful assembly and rioting while ragging
4. Public nuisance created during ragging
5. Violation of decency and moral through ragging
6. Injury to body, causing hurt or grievous hurt
7. Wrongful restraint
8. Wrongful confinement
9. Use of criminal force
10. Assault as well as sexual offences or unnatural offences
11. Extortion
12. Criminal trespass
13. Offences against property
14. Criminal intimidation
15. Attempts to commit any or all of the above-mentioned offences against the victim(s)
16. Threat to commit any or all of the above-mentioned offences against the victim(s)
17. Physical or psychological humiliation

RESPONSIBILITIES OF SQUAD IN-CHARGE OF
ANTI RAGGING COMMITTEE

Squad incharge will be responsible for the following in their areas:

1. They will form chart & carryout regular checks for any Ragging activity.
2. They will carryout surprise checks in probable areas of ragging.
3. In case of any incidence noticed on the spot, assessment of the incidence be made and necessary action to be taken and inform the control cell immediately.
4. Ensure anti-ragging instructions are displayed at prominent places.
5. Each squad in-charge will make detailed duty plan in respect of his squad and forward a list copy of the same to the control room.
6. Every squad in-charge will brief all members of his squad about their duties/action regarding anti-ragging.
